Recommendation

We recommend continuation of the extension of accreditation pending a full inspection of the provision within 12 months.

New summary statement

The British Council inspected and accredited MC Academy Manchester in May 2023 and MC Academy Liverpool in May 2024. The Accreditation Scheme assesses the standards of management, resources and premises, teaching, welfare, and safeguarding under 18s and accredits organisations which meet the overall standard in each area inspected (see www.britishcouncil.org/education/accreditation for details).

This private language school offers courses in general English for adults (18+) and young people (16+). Strengths were noted in the area of premises and facilities and learner management.

The inspection report noted a need for improvement in the areas of course design, leisure opportunities, and safeguarding under 18s.

Overall, the inspection report stated that the organisation met the standards of the Scheme.

Introduction

Background

MC Academy Manchester was founded in 2005 under the name of Manchester Central School of English (MCSE) and moved to its current premises in 2010. The school was rebranded as MC Academy in 2019 following plans to open additional premises in Liverpool. After a period during which these plans were put on hold, the Liverpool school began operating in February 2024. The purpose of the spot check was to assess the suitability of the provision in the new Liverpool extension.

Preparation

The inspector contacted the school in advance of the inspection to check on general availability of key staff, and student and teacher numbers. The Accreditation Unit provided the necessary background documentation.

Programme and persons present

Meetings were held with the executive director, the student experience manager, members of the student experience team responsible for enrolments and admissions, accommodation and administration, the ADoS, and two teachers. A further meeting was held remotely with the DoS and ADoS in the Manchester school.

Findings

Management

The student experience officer and her team are based in Liverpool and responsible for day-to-day operations. The Liverpool ADoS has academic responsibility, supported by the DoS in Manchester. Management and administration systems are common to both schools, and there is regular communication and exchange between the schools, including virtual and face-to-face meetings. Managers travel frequently between sites and staff are supported effectively in their roles through formal training as well as ongoing support. Publicity is generally clear but the frequently asked questions (FAQs) section of the website is insufficiently clear about accommodation arrangements (see below).

The school's action plan with points to be addressed from the previous inspection was made available; however, as the plan cites the full criterion in each case, rather than the specific point to be addressed, responses to some points were unclear.

Premises and resources

The school occupies part of a large building previously in use as a language school, with extensive space and facilities. The operation currently uses only a small part of the space available, leaving ample room for expansion. There is an outside area for use in good weather, and appropriate areas for staff and students. Resources for students and teachers are satisfactory.

Findings are reported in the Premises and facilities section below.

Teaching and learning

Teachers have relevant qualifications and receive day-to-day support from the ADoS, who has also carried out some observations which have been well received by teachers. However, he is not TEFLQ, and annual monitoring observation will need to be carried out by the Manchester DoS. Course design and syllabuses are common across both schools.

Welfare and student services

Both MC Academy schools have the same policies and procedures regarding welfare and student services. Security and health and safety procedures are in place. Appropriate pastoral care, information and advice are available. Residential accommodation is arranged through an agency; this is clear in publicity but not in the FAQ section of the website. The school is beginning to establish its own homestay provision; paperwork is not yet complete but appropriate systems are in use.

Safeguarding under 18s

Students aged 16–17 can enrol on adult courses, although no under 18s have been enrolled yet. The safeguarding policy and procedures established in Manchester will be followed in Liverpool; there is a designated safeguarding lead in each school.
